• Turn in any items that came with your Subaru when you first leased it, including keys, manuals and
cargo covers. You may be charged for any missing items.
Complete, sign and date an odometer statement and return it to us.
MPLETE YOUR RETURN
Complete Lease Turn-in form or contact us within 1 business day of vehicle turn-in to ensure that
we have the correct date and information to calculate your lease-end bill, if you have one.
Pay your lease-end bill. If you have charges at the end of your lease, your bill will arrive about 30-60
days after the vehicle is returned. If you turn-in your vehicle early, or there's a situatuion where the
vehicle has to be sold, expect your bill about 90–120 days after turn-in.
